This Limited Warranty certificate will warrant to the original purchaser at the time of original installation that the Baby-Loc Removable Mesh Fencing System, to which this warranty applies, is free from defects in material and workmanship under normal use, service and conditions, only when installation has been correctly made by qualified persons. Our obligation under this warranty shall be limited to furnishing – at no cost – a replacement fence, or, at our option, repairing any part or parts, which to our satisfaction prove thus defective within 12 months from the factory ship date.

We also warrant to the original purchaser that if it shall be disclosed to our satisfaction that the original Baby-Loc Fence fails under normal use, service and conditions, and if such disclosure is made within 5 years from the original factory shipping date, we will furnish a replacement Baby-Loc Fence of comparable model to such owner at a percentage of the current list price of the replacement Baby-Loc Fence, as follows:

The customer will pay 1/60 for each month or part thereof elapsed since the original factory shipping date, of the current list price of the replacement fence, plus a 10% service and handling charge. All repairs of replacements shall be F.O.B. Baby-Loc's plant. Pool Cover Corp./Baby-Loc shall not be liable for freight, installation, service or labor costs.

This limited warranty specifically covers the fence material, and fiberglass poles. This warranty does not cover incidental or consequential damages. Scratches or damages to the metal strips or fiberglass poles are not covered under this warranty.

This warranty is in lieu of any other warranty, expressed or implied, and of all other obligations or liabilities on our part, and we neither assume nor authorize any person to assume for us any other obligation or liability in connection with the sale of this product.

No warranty is given if the Baby-Loc Fence, to which this warranty applies, has been subject to misuse, neglect, abuse, alterations, metal or pole scratching, animal damage, or accidents. Damage caused by wind, storm, or any other acts of God are also not covered under this warranty.

This limited warranty applies within the Continental limits of the United States, Hawaii, Alaska and the Dominion of Canada only.

Any warranty claims must be accompanied by a copy of the original receipt or work order in order for this warranty to be deemed valid.

IMPORTANT: IN EXTREME HIGH WIND CONDITIONS, FENCE MUST BE REMOVED TEMPORARILY IN ORDER TO AVOID DAMAGE.

Note: Baby-Loc Fencing must be inspected periodically by the customer/owner of the fence, for any damage.

**Important: Keep in mind that Baby-Loc Fencing is intended only to add an extra layer of protection in your pool area. At NO time should it be considered a Safety Device, or take the place of Adult Supervision.
